
Would you like to be paid for saving water?

You may be eligible to participate in the ACSA Toilet Rebate Program

What do you have to do to qualify?

ACSA is offering up to \$100 per toilet to customers who replace older, water guzzling toilets with new, low-flow toilets

- 1. Must be pre-approved to participate.
- 2. Must be a direct customer of ACSA.
- 3. Must have authority to change the bathroom equipment in the facility.
- Toilet(s) being replaced must be older generation and use greater than 1.6 gallons per flush.



- 6. Participants agree to install water efficient showerheads, provided free of charge by ACSA. If different showerhead design is desired, receipt for purchase must be submitted to ACSA at time receipts for toilets are submitted. Up to \$5.00 per showerhead will be reimbursed. Showerheads that have previously been replaced with water efficient types will be subject to inspection.
- Customers must dispose of toilets so they cannot be reused, and toilet tank lids must be saved and provided to ACSA. If tankless toilets are replaced, toilet bowls must be saved for ACSA.
- 8. Participants agree to an installation verification visit.

Note: Some toilets installed in buildings after 1992 were low-flow. If your building was built after 1992, the ACSA will qualify you for a rebate upon verification of the toilets being older generation at the time of pick-up. If, in fact, the toilets are not older generation, they will NOT be picked up and you will NOT be eligible for a rebate.

How do you receive pre-approval?

Funding for this program is limited. It is offered on a first come, first served basis. Rebate is not guaranteed except by confirmation of approval, and only if program requirements are met.
